STORAGE INSTRUCTIONS

All G.A.P. Roofing, Inc. self-adhered roll membranes should be stored in their factory applied packaging. It is recommended that self-adhered products be stored inside a dry, protected warehouse at a temperature not exceeding 110°F. G.A.P. Roofing, Inc. recommends a maximum of 2 levels of stacking of all self-adhered products while in protected storage as stacking higher may damage the material.

APPLICATION INSTRUCTIONS

- Apply SA Rain & Ice Protection directly to the roof deck. Do not apply to shingles or other roof coverings.
- Apply only when the weather is dry and material interface temperatures (air, roof deck, membrane) are 40°F and rising.
- Start at the lowest point of the roof deck.
- Cut the SA Rain & Ice Protection to a suitable, workable length (typically between 9 and 15 feet).
- Lay the material flat in place, starting at the lowest point.
- Overlap seams by a minimum of 3 inches and at end laps by a minimum of 6 inches.
- Peel half of the release liner off and apply roll with firm and even pressure from the center to the outer edges.
- Remove the remaining half of the liner of install roll by applying pressure.
- When installing a metal drip edge, apply over the edge of the SA Ice & Rain Protection membrane at rakes and eaves.
- Be sure to follow all local building code recommendations and requirements with regards to the width of ice dam materials.
- If full roof coverage application is desired, proper venting of the structure is required.
- In steep slope applications (i.e. 3: 12 slope or higher) where back nailing will be required, be sure that all nails are covered by the overlapping next sheet.
- SA Rain & Ice Protection must be covered within 90 days of installation unless otherwise limited by local authorities.

Consult local building codes for specific requirements and a design professional for proper venting requirements.

This limited warranty does not cover labor or installation costs, leaks, fastener penetrations or other holes in the membrane, exposure over 180 days, low slope roofs or materials not manufactured by G.A.P.
